At our Zuni campus, 39 adults with intellectual disabilities are provided with supportive and residential services regardless of Medicaid waiver funding support. We provide on-campus activities and transportation for residents to community-based vocational, educational, day support, and other sheltered workshop opportunities to foster independence. We also provide social, cultural, entertainment, and travel outlets for residents, enabling them to have fulfilling life experiences. More information can be found at www.humankind.org.

HumanKind provides 37 adults with intellectual disabilities services through residential homes in a family setting. Services are provided regardless of Medicaid waiver funding support in five communities across the state: Fredericksburg, Lexington, South Hill, Stuarts Draft, and Lynchburg. At each location, we provide transportation for residents to community-based vocational, educational, day support, and sheltered workshop opportunities to foster independence. Residents are also provided with social, cultural, entertainment, and other activities, so they remain a part of the communities where they live and gain full and enriching life experiences.
