
Annual Report to the Public

This annual report to the public reflects program term 09/06/22-08/25/23 and budget period 12/01/22-11/30/23. Per Sec. 644(a)(2) of the Head Start Act of 2007, the annual report will contain the following information:


- A. The total amount of public and private funds received and the amount from each source.

B – Proposed Budgetary Expenditures




C – Enrollment

From 09/06/22-08/25/23, HumanKind Early Head Start served 87 children and 70 families (17 sibling groups). HumanKind submitted a Change in Scope application to the Office of Head Start on 9/9/22 to decrease funded enrollment from 80 children across 10 classrooms in Amherst, Bedford, and Lynchburg to 64 children across 8 classrooms in Bedford and Lynchburg. The Change in Scope was awarded on 6/22/23. There were several reasons HumanKind submitted the application almost two and a half years after awarded EHS funding in July 2020, including: multiple unsuccessful partnerships to find an affordable space to operate the 2 classrooms originally intended in Amherst; Amherst never fully enrolled in virtual services, like Bedford and Lynchburg; Amherst was never fully staffed.

EHS began the 2022-2023 program term operating 7 out of the 8 classrooms across Bedford and Lynchburg. Between November 2022-January 2023, EHS Lynchburg lost several staff and had difficulty replacing the staff, so HumanKind EHS and Policy Council made the difficult decision to temporarily close one of the Lynchburg classrooms as children aged out of the program in January 2023. The temporary closure of the Lynchburg classroom caused a decrease in program enrollment for February 2023 (see chart below). In June 2023, enrollment increased by 20% when HumanKind was awarded the Change in Scope, and enrollment increased slightly in August 2023 after reopening the temporarily closed classrooms across Bedford and Lynchburg. EHS is almost fully staffed with plans to open the 8th funded classroom in the 2023-2024 program term.

During this program term, 94.3% of enrolled children were categorically eligible for Early Head Start services due to living between 0-100% of the federal poverty level, receiving public assistance, or experiencing homelessness or foster care. The remaining 5.7% of enrolled children were found otherwise eligible. Of the 5.7% of children otherwise eligible, 2.3% of children were enrolled due to a development delay or disability, and 3.4% of children were enrolled because they had a sibling already enrolled in EHS and the family would benefit from continuity, even though the families improved their incomes status.



D – Monitoring Review and Financial Audit

HumanKind's most recent financial audit dated May 24, 2023, was clean with no findings nor observations. Early Head Start did not have an Office of Head Start Monitoring Review this year. A Focus Area 2 (FA2) Monitoring Review will be conducted during Program Term 2023-2024.

E – Medical and Dental Services

From 09/0/22-08/25/23, 100% of children enrolled in Early Head Start have an ongoing source of medical care, and 60% have an ongoing source of dental care. The dental care rate is low, because providers in the area do not begin scheduling appointments for children until 3 or 4 years of age due to limited provider availability, and most of our children are under age 3. HumanKind established an MOA with Johnson Health Center on August 24, 2022, to bring their mobile dental unit to Early Head Start centers semiannually, so that all enrolled children will have access to age-appropriate preventative dental care.

F – **Parent Involvement**

From 09/06/22-08/25/23, HumanKind Early Head Start offered several ways for families to be involved with Early Head Start staff and community members.

 - Total in-person meetings held in centers: 6
- Total bi-monthly Policy Council meetings held: 5
- Parent-led Clothing Exchange for EHS families, separate events held at both centers in December 2023
- Bedford Center hosted Cinco De Mayo event for parents to enjoy Mexican food and engage in fun activities with their children and other families who participated
- Two EHS Policy Council members joined EHS Health Services Advisory Committee meeting with medical professionals and community members at the May 2023 meeting

- Two EHS family stories were featured in Summer HumanKind Newsletter
- Bedford Center hosted end of the academic year event for parents to enjoy ice cream and engage in music from Melody Makers with their children and other families who participated
- Three EHS parents joined EHS staff as substitute teachers
- Family Outcome Assessments & Goal Setting:
 - 100% of families enrolled by May 2023 completed at least one FOA/Goal Setting interview with Family Engagement Specialists
- Children's family had one or more home visit conducted by teaching staff:
 - o 68% of Bedford children
 - o 67% of Lynchburg children
- Children's family had one or more parent conference held in center:
 - o 73% of Bedford children
 - o 73% of Lynchburg children

G – Kindergarten Readiness

HumanKind Early Head Start utilizes the HighScope Curriculum to promote kindergarten readiness. The Desired Results Developmental Profile (DRDP) is used to assess children's progress toward kindergarten readiness. Per the DRDP Child Development Summary (see report below), the median scores of children from Summer 2022 to Summer 2023 progressed at least one developmental level (exploring earlier to exploring later) in each developmental domain (Approaches to Learning, Social and Emotional Development, Language and Literacy, Cognition, Physical Development).
